What is a management system?

- Set of interacting elements
 of an organisation to
 establish policies, and
 objectives, and processes to
 achieve those objectives!
 - Clause 3.2.1ISO50001:2018
- Your energy management system SHOULD be a TOOL to deliver what you want to achieve in the organisation



Why do ISO 50001 systems require so much preparation for audit?

 Because a LOT of organisations that are certified to ISO 50001 do NOT have Energy Management Systems

 Lots of organisations have Energy Accounting
 Systems!

Management Systems are supposed to be aligned to the purposes of the





Context of the organisation Production Environment

Priority 1: Product
Quality + legal
compliance

Priority 2: Meet production deadlines/ max product output

Priority 3: Resource Efficiency (including energy)

Context of the organisation Services Provider

Priority 1: Service delivery + legal compliance

Priority 2: Meet customer demand deadlines/ max service output

Priority 3: Resource Efficiency (including energy)

Improvement Means Change!

- To deliver improvement of scale in any business requires a real understanding of the organisation and the potential impacts of what you do on the organisation.
- Without getting that real understanding in the first place limits the scale of improvement you will achieve.





For each SEU "determine current performance"

- In my opinion this is the clause of the standard that is least understood and least complied with across the EnMS world
- When this is not done properly Energy Performance improvement is always constrained.
- Benchmark yourself against best practice for each SEU – Get to know what improvement can be



Energy Performance Indicators

- The purpose of an Energy
 Performance Indicator is to enable the organisation to demonstrate improvement
- EnPI's and SEU's do NOT need to be seamlessly linked
- Having EnPI's at Building Level and SEU's at system level is compliant with the standard – and often works quite well.




Internal Audits (another pet peeve)

- Internal audits are primarily there to check if your management system is working
 - Not to see if you meet the requirements of the standard
 - Not to see if you are complying with your management system
- No internal audit training course I am aware of seems to have read the 2018 standard (including training delivered by the certification bodies)

Beware of Consultants (I am one)

- To some consultant's, knowledge is power – and they will do their best to ensure that your EnMS is reliant on their input
- An EnMS that maximises the use of external resources and minimises the use of internal resources will always limit the potential improvement as it will never look close enough at core business delivery.

Gives ability to look at data across the organization and interrogate it in a manner never previously possible!
